Quality policy 2021/2022

To achieve the long-term goal of the Faculty of Public Policy and Public Administration DANUBIUS COLLEGE and to ensure the internal quality system according to §87a of Act No. 131/2002 Coll. the management of FPP AND PA declares the following quality policy:

1. The Quality Policy of FPP AND PA is guided by and in accordance with the Quality Policy of Danubius College and was created as an implementation of and in continuation of the Quality Policy of Danubius College in Sládkovičovo.
2.
